- To win and represent the ISA-Utah Chapter, I have been a member in good standing of the ISA UT-Chapter since February 28, 2024, and live and work within 300 miles of Salt Lake City, Utah.
- b. I will attend the equipment check on Thursday, June 6, 2024 at the Logan Tabernacle. The equipment I bring to the equipment check will be used at the tree climbing event, is appropriate for tree climbing, and meets or exceeds minimum accepted industry safety standards.
- c. I understand a misconduct disqualification will be enforced by the Head Judge on any competitor who has displayed inappropriate, unprofessional, and/or unsportsmanlike behavior during participation in or after the completion of an event. Event Head Judges will enforce the rules for their individual event including infractions of the misconduct rule.
- d. I understand that I may be advised in advance of the competition of any rule changes or modifications to the competition setup deemed necessary for the safety of the competitors or the competitive requirements of the event.
- e. If I win the Master's Challenge, I will represent the ISA UT-Chapter on October 24-27, 2024 in Atlanta, GA, and I am or will be an ISA member to compete at the ITCC event.

Logan Tabernacle Standard Rules and Conditions. Property denotes Logan Tabernacle grounds.

- a. Comply with all applicable Federal, State, and local laws, regulations, rules, and ordinances.
